



Business Description

Cia Paranaense De Energia Copel is engaged in the areas of generation, transmission, commercialization and distribution of energy. It operates a comprehensive and effective electrical system with its own generating plants, transmission lines, substations, electrical lines and grids of the distribution system. The company's reportable segments include Power generation and transmission, Power distribution, GAS, Power sale, Holding and Services. Majority of its revenue is generated from the Power generation and transmission segment under which it produces electricity from hydraulic, wind, and thermal projects and provides services of transmission and transformation of electric power and other related services.

Valuation ^Qas of 16 May 2024

Morningstar affirms a 3-star quantitative rating for Cia Paranaense De Energia. We calculate this outcome using the company's underlying model-driven valuation and uncertainty scores.

The stock's last closing price was 1.62, a discount of 7.27% to its Quantitative Fair Value estimate of 1.75. This discount has ranged between 18.38% and 2.12% over the past year. The stock's price to fair value ratio is at the 79th percentile in our global equity coverage universe for this methodology and at the 71st percentile relative to its peers in the utilities sector.

Cia Paranaense De Energia furthermore holds a High quantitative uncertainty rating.

The company's quantitative star rating dates to after 11/24/2023, before which it was 4-star. Similarly, the firm's uncertainty rating changed from Very High to High after 05/10/2024.

We examine the financials and market statistics for Cia Paranaense De Energia to determine these ratings. Its earnings yield is 7.98% and its annualized trailing 12-month volatility is 17.39%. These fall at the 80th and 14th percentiles in the equity universe and at the 74th and 25th in the utilities sector, respectively.

Economic Moat ^Q as of 16 May 2024

Morningstar maintains a quantitative moat rating of None on the company. The firm's quantitative moat score of 0.16 sits at the 12th percentile in the utilities sector. This is a decrease from 0.59, the maximum of its moat scores over the past year.

The quantitative financial health rating for Cia Paranaense De Energia is Moderate. Its financial health score, termed Distance to Default, sits at the 62nd percentile in the universe and 78th percentile in the sector.

The significant drivers of these ratings are the company's book value yield and enterprise value-to-market value ratio. The book value yield for Cia Paranaense De Energia is 85.01%, and its enterprise value-to-market value ratio is 1.36. They sit at the 65th and 73rd percentile in the global equity universe, respectively.


Cia Paranaense De Energia maintains earnings per share of 0.79. The company further earns a return on invested capital of 6.22%. The shares offer a dividend yield of 4.38%. These values are calculated over a trailing 12-month period.


As of last market close, Čia Paranaense De Energia has a price-to-earnings ratio of 11.99, falling below the 34th percentile in its sector (where a lower percentile means a lower ratio) and ranging between 11.82 and 23.69 over the past year. The company's price-to-free cash flow ratio is 7.73, falling at the 36th percentile in its sector and ranging between 7.08 and 13.25 over the past year.

Quantitative Equity Report Overview

The quantitative report on equities consists of data, statistics and quantitative equity ratings on equity securities. Morningstar, Inc.'s quantitative equity ratings are forward looking and are generated by a statistical model that is based on Morningstar Inc.'s analyst-driven equity ratings and quantitative statistics. Quantitative Equity Ratings

Morningstar's quantitative equity ratings consist of: (i) Quantitative Fair Value Estimate, (ii) Quantitative Star Rating, (iii) Quantitative Uncertainty, (iv) Quantitative Economic Moat, and (v) Quantitative Financial Health (collectively the "Quantitative Ratings).

The Quantitative Ratings are calculated daily and derived from the analyst-driven ratings of a company's peers as determined by statistical algorithms. Morningstar, Inc. ("Morningstar", "we", "our") calculates Quantitative Ratings for companies whether or not it already provides analyst ratings and qualitative coverage. In some cases, the Quantitative Ratings may differ from the analyst ratings because a company's analyst-driven ratings can significantly differ from other companies in its peer group.

- i. Quantitative Fair Value Estimate: Intended to represent Morningstar's estimate of the per share dollar amount that a company's equity is worth today. Morningstar calculates the Quantitative Fair Value Estimate using a statistical model derived from the Fair Value Estimate Morningstar's equity analysts assign to companies. - ii. **Quantitative Economic Moat:** Intended to describe the strength of a firm's competitive position. It is calculated using an algorithm designed to predict the Economic Moat rating a Morningstar analyst would assign to the stock. The rating is expressed as Narrow, Wide, or None.

Narrow – assigned when the probability of a stock receiving a "Wide Moat" rating by an analyst is greater than 70% but less than 99%.

Wide — assigned when the probability of a stock receiving a "Wide Moat" rating by an analyst is greater than 99%.

None — assigned when the probability of an analyst receiving a "Wide Moat" rating by an analyst is less than 70%.

iv. **Quantitative Uncertainty:** Intended to represent Morningstar's level of uncertainty about the accuracy of the Quantitative Fair Value Estimate. Generally, the lower the Quantitative Uncertainty, the narrower the potential range of outcomes for that particular company. The rating is expressed as Low, Medium, High, Very High, and Extreme.

Low – the interquartile range for possible fair values is less than 10%
Medium – the interquartile range for possible fair values is less than 15%
but greater than 10%

High – the interquartile range for possible fair values is less than 35% but greater than 15%

Very High – the interquartile range for possible fair values is less than 80% but greater than 35%

v. **Quantitative Financial Health:** Intended to reflect the probability that a firm will face financial distress in the near future. The calculation uses a predictive model designed to anticipate when a company may default on its financial obligations. The rating is expressed as Weak, Moderate, and Strong.
