


Business Description

Gerdau SA produces steel and steel products. The company operates in civil construction, agriculture, automotive, iron ore, exports, research and development, and home steel products sectors. It offers products such as nails, rebar, columns, billets, slabs, tribar tutor, mechanical construction bars, reinforced steel locks. The company's geographical segment includes Brazil Operations; North America Operations; South America Operations as well as Special Steel Operations. It derives majority of the revenue from the North America Operations segment.

Valuation ^Qas of 16 May 2024

Morningstar maintains a 4-star quantitative star rating for Gerdau, derived from the firm's valuation and uncertainty scores.

The company's shares last closed at 3.58, below our quantitative fair value estimate of 4.62. These shares have traded between a 34.01% and 8.44% discount to their fair value estimate over the past year. In Morningstar's equity coverage universe for this methodology, the company's valuation rating lands at the 49th percentile; in the basic materials sector, the firm's score lies at the 68th percentile (meaning the shares are more undervalued than 68% of stocks in the sector).

Furthermore, Gerdau maintains a quantitative valuation uncertainty rating of Very High.

The company has held this star rating since the previous rating of 3, which was last assigned on 02/02/2024. The uncertainty rating for Gerdau has remained Very High since the previous rating of High, which was last assigned on 05/14/2024.

The key factors behind these ratings are the company's earnings yield and drawdown. The earnings yield is 16.01%, and its maximum trailing 12-month maximum drawdown is 29.57%. The earnings yield

falls above the 95th percentile in the basic materials sector while the drawdown is at the 29th percentile. Over the past year, the company's earnings yield has ranged between 27.80% and 15.73%; its drawdown has ranged between 29.57% and 25.17%.

Economic Moat ^Q as of 16 May 2024

Morningstar maintains a quantitative moat rating of None on the company. The firm's quantitative moat score of 0.21 sits at the 25th percentile in the basic materials sector. This is a decrease from 0.49, the maximum of its moat scores over the past year. The quantitative financial health rating for Gerdau is Moderate. Its financial health score, termed Distance to Default, sits at the 62nd percentile in the universe and 77th percentile in the sector.

The significant drivers of these ratings are the company's book value yield and enterprise value-to-market value ratio. The book value yield for Gerdau is 127.77%, and its enterprise value-to-market value ratio is 1.16. They sit at the 81st and 61st percentile in the global equity universe, respectively.

Fundamentals as of 16 May 2024

Gerdau reports earnings per share of 3.11. Its return on invested capital is 10.75%. The company maintains a dividend yield of 8.31%, paying out 45.08% of earnings. These values are calculated over a trailing 12-month period.

As of last market close, Gerdau has a price-to-earnings ratio of 6.45, falling at the 12th percentile in its sector (where a lower percentile means a lower ratio) and ranging between 4.35 and 6.8 over the past year. The company's price-to-free cash flow ratio is 9.27, falling at the 32nd percentile in its sector and ranging between 6.66 and 14.34 over






Quantitative Equity Report Overview

The quantitative report on equities consists of data, statistics and quantitative equity ratings on equity securities. Morningstar, Inc.'s quantitative equity ratings are forward looking and are generated by a statistical model that is based on Morningstar Inc.'s analyst-driven equity ratings and quantitative statistics. Given the nature of the quantitative report and the quantitative ratings, there is no one analyst in which a given report is attributed to; however, Mr. Lee Davidson, Head of Quantitative Research for Morningstar, Inc., is responsible for overseeing the methodology that supports the quantitative equity ratings used in this report. Quantitative Equity Ratings

Morningstar's quantitative equity ratings consist of: (i) Quantitative Fair Value Estimate, (ii) Quantitative Star Rating, (iii) Quantitative Uncertainty, (iv) Quantitative Economic Moat, and (v) Quantitative Financial Health (collectively the "Quantitative Ratings).

The Quantitative Ratings are calculated daily and derived from the analyst-driven ratings of a company's peers as determined by statistical algorithms. Morningstar, Inc. ("Morningstar", "we", "our") calculates Quantitative Ratings for companies whether or not it already provides analyst ratings and qualitative coverage. In some cases, the Quantitative Ratings may differ from the analyst ratings because a company's analyst-driven ratings can significantly differ from other companies in its peer group.

- i. Quantitative Fair Value Estimate: Intended to represent Morningstar's estimate of the per share dollar amount that a company's equity is worth today. Morningstar calculates the Quantitative Fair Value Estimate using a statistical model derived from the Fair Value Estimate Morningstar's equity analysts assign to companies. - ii. **Quantitative Economic Moat:** Intended to describe the strength of a firm's competitive position. It is calculated using an algorithm designed to predict the Economic Moat rating a Morningstar analyst would assign to the stock. The rating is expressed as Narrow, Wide, or None.

Narrow – assigned when the probability of a stock receiving a "Wide Moat" rating by an analyst is greater than 70% but less than 99%.

Wide — assigned when the probability of a stock receiving a "Wide Moat" rating by an analyst is greater than 99%.

None — assigned when the probability of an analyst receiving a "Wide Moat" rating by an analyst is less than 70%.

iv. **Quantitative Uncertainty:** Intended to represent Morningstar's level of uncertainty about the accuracy of the Quantitative Fair Value Estimate. Generally, the lower the Quantitative Uncertainty, the narrower the potential range of outcomes for that particular company. The rating is expressed as Low, Medium, High, Very High, and Extreme.

Low – the interquartile range for possible fair values is less than 10%
Medium – the interquartile range for possible fair values is less than 15%
but greater than 10%

High – the interquartile range for possible fair values is less than 35% but greater than 15%

Very High – the interquartile range for possible fair values is less than 80% but greater than 35%

v. **Quantitative Financial Health:** Intended to reflect the probability that a firm will face financial distress in the near future. The calculation uses a predictive model designed to anticipate when a company may default on its financial obligations. The rating is expressed as Weak, Moderate, and Strong.
