



Business Description

Grupo Financiero Banorte SAB de CV is a Mexican financial services company. The company offers a wide variety of products and services including banking services, brokerage, wholesale banking, leasing, factoring, insurance, pensions, and retirement savings. It operates locally in Mexico.

Valuation as of 16 May 2024

Morningstar affirms a 3-star quantitative rating for Grupo Financiero Banorte. We calculate this outcome using the company's underlying model-driven valuation and uncertainty scores.

The stock's last closing price was 9.60, in-line with its Quantitative Fair Value estimate of 9.73. The stock has been trading between a 18.66% discount and 4.68% premium to its quantitative fair value over the past year. The stock's price to fair value ratio is at the 87th percentile in our global equity coverage universe for this methodology and at the 91st percentile relative to its peers in the financial services sector.

Grupo Financiero Banorte furthermore holds a High quantitative uncertainty rating.

The company's quantitative star rating remains unchanged over the past year. The firm's uncertainty rating changed from Very High to High after 05/06/2024.

We examine the financials and market statistics for Grupo Financiero Banorte to determine these ratings. Its return on assets is 2.37 and its annualized trailing 12-month volatility is 21.01%. These fall at the 55th and 23rd percentiles in the equity universe and at the 72nd and 42nd in the financial services sector, respectively.

Economic Moat ^Q as of 16 May 2024

Quantitatively, we do not believe Grupo Financiero Banorte has an economic moat. Its moat score of 0.52 corresponds to the 47th percentile in the financial services sector. Furthermore, this rating last differed from its previous rating of Narrow on 05/01/2024, when the company's moat score fell from its maximum of 0.84 (score of 1 indicates greatest economic moat).

The company also maintains a quantitative financial health rating of Strong. Its score sits at the 95th percentile overall and the 78th percentile in the sector.

Examining the company's financials and market statistics, we find these ratings are principally driven by its book value yield and annualized trailing 12-month volatility. The book value yield is 52.16%, sitting at the 28th percentile in the financial services sector. The company's annualized trailing 12-month volatility is 21.01%, corresponding to the 23rd percentile in the equity coverage universe and the 42nd percentile in the sector.

Fundamentals as of 16 May 2024

Grupo Financiero Banorte maintains earnings per share of 18.31. The shares offer a dividend yield of 7.26%. These values are calculated over a trailing 12-month period.

As of last market close, Grupo Financiero Banorte has a price-to-earnings ratio of 9.51, falling below the 39th percentile in its sector (where a lower percentile means a lower ratio) and ranging between 7.94 and 10.24 over the past year. The company's price-to-free cash flow ratio is 7.9, falling at the 47th percentile in its sector and ranging between 4.57 and 9.75 over the past year.





Quantitative Equity Report Overview

The quantitative report on equities consists of data, statistics and quantitative equity ratings on equity securities. Morningstar, Inc.'s quantitative equity ratings are forward looking and are generated by a statistical model that is based on Morningstar Inc.'s analyst-driven equity ratings and quantitative statistics. Quantitative Equity Ratings

Morningstar's quantitative equity ratings consist of: (i) Quantitative Fair Value Estimate, (ii) Quantitative Star Rating, (iii) Quantitative Uncertainty, (iv) Quantitative Economic Moat, and (v) Quantitative Financial Health (collectively the "Quantitative Ratings).

The Quantitative Ratings are calculated daily and derived from the analyst-driven ratings of a company's peers as determined by statistical algorithms. Morningstar, Inc. ("Morningstar", "we", "our") calculates Quantitative Ratings for companies whether or not it already provides analyst ratings and qualitative coverage. In some cases, the Quantitative Ratings may differ from the analyst ratings because a company's analyst-driven ratings can significantly differ from other companies in its peer group.

- i. Quantitative Fair Value Estimate: Intended to represent Morningstar's estimate of the per share dollar amount that a company's equity is worth today. Narrow – assigned when the probability of a stock receiving a "Wide Moat" rating by an analyst is greater than 70% but less than 99%.

Generally, the lower the Quantitative Uncertainty, the narrower the potential range of outcomes for that particular company. The rating is expressed as Low, Medium, High, Very High, and Extreme.

Medium – the interquartile range for possible fair values is less than 15%

v. **Quantitative Financial Health:** Intended to reflect the probability that a firm will face financial distress in the near future. The calculation uses a predictive model designed to anticipate when a company may default on its financial obligations. The rating is expressed as Weak, Moderate, and Strong.

Weak — assigned when Quantitative Financial Health < 0.2

Moderate — assigned when Quantitative Financial Health is between 0.2

and 0.7

Strong – assigned when Quantitative Financial Health > 0.7
