Clarification:

Regarding the Official Letter 1486/2021-SLS, Bradespar clarifies that it is **not** aware of any material non-public fact or information that could justify any variation in the trading of securities issued by the Company.

Regarding this, it should also be mentioned that on October 29, 2021, after the closing of B3's trading session, the Company disclosed to the market a Material Fact about the submission to the Board of Directors of a proposal for the payment of dividends, which was approved at the meeting of the body held on November 8, 2021, according to the Notice to the Shareholders disclosed on the same date.

With regard to the deadline for submitting this reply, the Company clarifies that, due to a problem with the e-mail address on the Company's Registration Form - which is already being investigated so as to prevent a recurrence - it only became aware of the sending of Letter 1486/2021-SLS at the end of November 9, 2021.

Under the terms of the applicable legislation, the Company informs that it will maintain its shareholders and the market in general informed about any relevant act or fact related to its business.
