**Subject: CNPE Meeting - Proposal for a Resolution on the Angra 3 nuclear thermoelectric power plant**

Mr. CEO,

1. As you know, the National Energy Policy Council - CNPE comes following the process of feasibility and completion of the Angra 3 Thermonuclear Plant.
2. With the enactment of Law No. 14.120, of March 1, 2021, it was up to this collegiate to approve the energy price of the plant that will result from the studies being carried out by the Bank National Economic and Social Development - BNDES, pursuant to art. 10, §3 of the aforementioned law.
3. Considering, however, the request of this Company, contained in Letter CTA-01824/2021, of September 28, 2021, that, in order to comply with the schedule of the capitalization process of the Eletrobras, referred to in Law No. 14.182, of July 12, 2021, the indication would be necessary in this moment, of parameters that should be used to define the price of electricity produced by Usina Termonuclear Angra 3, I would like to inform you that the CNPE will deliberate, on the 20th of October 2021, regarding those parameters.
