PAR FUNDO DE INVESTIMENTO EM AÇÕES, informing that on March 23, 2023, the Fund reached a consolidated position of 14,454,097 (fourteen million , four hundred and fifty-four thousand and ninety-seven) Class B preferred shares, issued by Eletrobras, thus making up an approximate shareholding percentage of 5.1632%.

In the referred correspondence, PLURAL INVESTIMENTOS GESTÃO DE RECURSOS LTDA informs that it has voting powers on behalf of the Fund and that it is a minority investment, which does not aim to change the control or administrative and organizational structure of Eletrobras.

On March 23, 2023, it was verified that the Fund has a consolidated position of 14,454,097 (fourteen million four hundred and fifty-four thousand and ninety-seven) Class B preferred shares issued by Eletrobrás ("ELET6"), thus making up an approximate percentage of 5.1632% (five and sixteen and thirty-two thousandths percent) of the Class B preferred shares issued by ELETROBRAS.

Plural Investimentos also informs that it has voting powers on behalf of the Fund and that it is it is a minority investment that does not aim to change the control or administrative and organizational structure of ELETROBRAS, and that the Fund will not increase its participation with the reason of changing the control of ELETROBRAS or its administrative and organizational structure.
