Dear Sirs,

1. The undersigned Invesco Ltd., on behalf of some of its clients and subsidiaries, including Invesco Advisers, Inc. and Invesco Capital Management LLC (“**IVZ**”), hereby informs that, due to an inadvertent oversight in IVZ Equity Holdings led to inaccurate information, which resulted in an error in the information sent to the disclosure of material equity holding sent by IVZ to CIA PARANAENSE DE ENERGIA – COPEL (“**COPEL**”) and, consequently, in the Notice to the Market disclosed by COPEL on November 12, 2025.
2. After review of the disclosed information, it was determined that IVZ currently holds 2,330,639 preferred shares of COPEL, representing approximately 0.138% of the total of preferred shares issued by COPEL, and therefore does not hold material equity of COPEL for purposes of the disclosure obligations under CVM Resolution No. 44, dated August 23, 2021.
3. Considering the above, IVZ hereby requests COPEL’s Investors Relations Officer to disclose this communication and the corrected information provided herein to CVM and to the relevant authorities, in accordance with the applicable regulations.

Prezados Senhores,

1. A abaixo assinada Invesco Ltd., vem, em nome de alguns de seus clientes e de suas subsidiárias, incluindo Invesco Advisers, Inc. e Invesco Capital Management LLC (“**IVZ**”), informar que, por uma falha inadvertida que levou a informações imprecisas, houve um equívoco na informação constante da divulgação de participação acionária relevante enviada à CIA PARANAENSE DE ENERGIA – COPEL (“**COPEL**”) e, consequentemente, no Comunicado ao Mercado divulgado pela COPEL em 12 de novembro de 2025.
2. Após a revisão das informações divulgadas, foi apurado que a IVZ detém, na presente data, 2.330.639 ações preferenciais de emissão da COPEL, representando aproximadamente 0,138% do total das ações preferenciais emitidas pela COPEL, de tal modo que a IVZ não possui participação relevante para fins das obrigações de divulgação previstas na Resolução CVM nº 44, de 23 de agosto de 2021.
3. Considerado o disposto acima, a IVZ, por meio desta, solicita ao Diretor de Relações com Investidores da COPEL a divulgação desta comunicação e das informações corrigidas aqui previstas à CVM e aos demais órgãos competentes, nos termos da regulamentação aplicável.
