



Business Description

Gerdau SA produces steel and steel products. The company operates in civil construction, agriculture, automotive, iron ore, exports, research and development, and home steel products sectors. It offers products such as nails, rebar, columns, billets, slabs, tribar tutor, mechanical construction bars, reinforced steel locks. The company's geographical segment includes Brazil Operations; North America Operations; South America Operations as well as Special Steel Operations. It derives majority of the revenue from the North America Operations segment.

Valuation ^Qas of 7 May 2024

Morningstar affirms a 4-star quantitative rating for Gerdau. We calculate this outcome using the company's underlying model-driven valuation and uncertainty scores.

The stock's last closing price was 3.64, a discount of 26.63% to its Quantitative Fair Value estimate of 4.96. This discount has ranged between 34.01% and 8.44% over the past year. The stock's price to fair value ratio is at the 44th percentile in our global equity coverage universe for this methodology and at the 64th percentile relative to its peers in the basic materials sector.

Gerdau furthermore holds a Very High quantitative uncertainty rating.

The company's quantitative star rating dates to after 02/02/2024, before which it was 3-star. Similarly, the firm's uncertainty rating changed from High to Very High after 05/01/2024.

We examine the financials and market statistics for Gerdau to determine these ratings. Its earnings yield is 15.73% and its trailing 12-month maximum drawdown is 27.04%. These fall at the 94th and 45th percentiles in the equity universe and at the 95th and 29th in the basic materials sector, re-

spectively.

Economic Moat as of 7 May 2024

With a Morningstar quantitative moat rating of None, the quantitative moat score for Gerdau falls at the 28th percentile in both the basic materials sector and equity coverage universe. The company has maintained its None quantitative moat rating for the last year.

We also assign a Moderate quantitative financial health rating to Gerdau. The company's raw score on this metric, termed Distance to Default, ranks at the 62nd percentile overall and 77th in the basic materials sector. Furthermore, this financial health rating has stayed Moderate over the last year.

Supporting these ratings are the company's book value yield and enterprise value-to-market value ratio. The book value yield of 125.49%, ranks at the 80th percentile in the covered equity universe and at the 78th percentile among its peers. Meanwhile, its enterprise value-to-market value ratio of 1.16, falls at the 61st percentile in the universe and the 69th percentile in the basic materials sector.


Gerdau reports earnings per share of 3.11. Its return on invested capital is 10.75%. The company maintains a dividend yield of 8.31%, paying out 45.08% of earnings. These values are calculated over a trailing 12-month period.


As of last market close, Gerdau has a price-to-earnings ratio of 6.48, falling at the 12th percentile in its sector (where a lower percentile means a lower ratio) and ranging between 4.35 and 6.8 over the past year. The company's price-to-free cash flow ratio is 9.32, falling at the 31st percentile in its sector and ranging between 6.66 and 14.34 over the past year.

Quantitative Equity Report Overview

The quantitative report on equities consists of data, statistics and quantitative equity ratings on equity securities. Morningstar, Inc.'s quantitative equity ratings are forward looking and are generated by a statistical model that is based on Morningstar Inc.'s analyst-driven equity ratings and quantitative statistics. Quantitative Equity Ratings

Morningstar's quantitative equity ratings consist of: (i) Quantitative Fair Value Estimate, (ii) Quantitative Star Rating, (iii) Quantitative Uncertainty, (iv) Quantitative Economic Moat, and (v) Quantitative Financial Health (collectively the "Quantitative Ratings).

The Quantitative Ratings are calculated daily and derived from the analyst-driven ratings of a company's peers as determined by statistical algorithms. Morningstar, Inc. ("Morningstar", "we", "our") calculates Quantitative Ratings for companies whether or not it already provides analyst ratings and qualitative coverage. In some cases, the Quantitative Ratings may differ from the analyst ratings because a company's analyst-driven ratings can significantly differ from other companies in its peer group.

- i. Quantitative Fair Value Estimate: Intended to represent Morningstar's estimate of the per share dollar amount that a company's equity is worth today. - ii. **Quantitative Economic Moat:** Intended to describe the strength of a firm's competitive position. It is calculated using an algorithm designed to predict the Economic Moat rating a Morningstar analyst would assign to the stock. The rating is expressed as Narrow, Wide, or None.

Narrow – assigned when the probability of a stock receiving a "Wide Moat" rating by an analyst is greater than 70% but less than 99%.

iv. **Quantitative Uncertainty:** Intended to represent Morningstar's level of uncertainty about the accuracy of the Quantitative Fair Value Estimate. Generally, the lower the Quantitative Uncertainty, the narrower the potential range of outcomes for that particular company. The rating is expressed as Low, Medium, High, Very High, and Extreme.

Low – the interquartile range for possible fair values is less than 10%
Medium – the interquartile range for possible fair values is less than 15%

v. **Quantitative Financial Health:** Intended to reflect the probability that a firm will face financial distress in the near future. The calculation uses a predictive model designed to anticipate when a company may default on its financial obligations. The rating is expressed as Weak, Moderate, and Strong.
