



Business Description

Corporacion Geo SAB de CV is a developer of housing estates. The company through its subsidiaries is engaged in design, development, construction, marketing, sales and delivery of affordable houses. The group's business model is focused mainly on the entry level and economic segments, which are supported by government policies. Geographically, the firm has its operation across over 20 states in Mexico.

Valuation as of 4 Apr 2024

Morningstar maintains a 3-star quantitative star rating for Corporacion Geo, derived from the firm's valuation and uncertainty scores.

The company's shares last closed at 0.0410, above our quantitative fair value estimate of 0.0383. These shares have traded between a 23.36% discount and 26.76% premium to their fair value estimate over the past year. In Morningstar's equity coverage universe for this methodology, the company's valuation rating lands at the 94th percentile, in the consumer cyclical sector, the firm's score lies at the 93rd percentile (meaning the shares are more undervalued than 93% of stocks in the sector).

Furthermore, Corporacion Geo maintains a quantitative valuation uncertainty rating of Very High.
The company has held this star rating over the past year. The uncertainty rating for Corporacion Geo has remained Very High since the previous rating

has remained Very High since the previous rating of Extreme, which was last assigned on 03/29/

The key factors behind these ratings are the company's earnings yield and return on assets. The earnings yield is -632.93%, and its maximum return on assets is 4.10. The earnings yield falls below the 5th percentile in the consumer cyclical sector while the return on assets is at the 59th percentile. Over

the past year, the company's earnings yield has ranged between -632.93% and -632.93%; its return on assets has ranged between 4.10 and 2.69.

Economic Moat ^Qas of 4 Apr 2024

Morningstar maintains a Narrow quantitative moat rating on the company. The firm's quantitative moat score of 0.91 sits at the 89th percentile in the consumer cyclical sector. This is a decrease from 0.97, the maximum of its moat scores over the past year.

The quantitative financial health rating for Corporacion Geo is Strong. Its financial health score, termed Distance to Default, sits at the 75th percentile in the universe and 79th percentile in the sector

The significant drivers of these ratings are the company's book value yield and enterprise value-to-market value ratio. The book value yield for Corporacion Geo is -873.65%, and its enterprise value-to-market value ratio is 1.43. They sit at the 5th and above the 75th percentile in the global equity universe, respectively.





Quantitative Equity Report Overview

The quantitative report on equities consists of data, statistics and quantitative equity ratings on equity securities. Morningstar, Inc.'s quantitative equity ratings are forward looking and are generated by a statistical model that is based on Morningstar Inc.'s analyst-driven equity ratings and quantitative statistics. The Quantitative Ratings are calculated daily and derived from the analyst-driven ratings of a company's peers as determined by statistical algorithms. Morningstar, Inc. ("Morningstar", "we", "our") calculates Quantitative Ratings for companies whether or not it already provides analyst ratings and qualitative coverage. In some cases, the Quantitative Ratings may differ from the analyst ratings because a company's analyst-driven ratings can significantly differ from other companies in its peer group.

- i. Quantitative Fair Value Estimate: Intended to represent Morningstar's estimate of the per share dollar amount that a company's equity is worth today. Narrow – assigned when the probability of a stock receiving a "Wide Moat" rating by an analyst is greater than 70% but less than 99%.

Generally, the lower the Quantitative Uncertainty, the narrower the potential range of outcomes for that particular company. The rating is expressed as Low, Medium, High, Very High, and Extreme.

v. **Quantitative Financial Health:** Intended to reflect the probability that a firm will face financial distress in the near future. The calculation uses a predictive model designed to anticipate when a company may default on its financial obligations. The rating is expressed as Weak, Moderate, and Strong.
